A. Safety Committee Update

Lead testing – Renée Simas

- The state deadline to qualify to apply for testing reimbursement is to act prior to 12/1/16. Testing need not be completed by then but invoices are needed to submit.
- For testing process relied on EPA's 3Ts document
- Renée suggests Shari Scholz as the school's testing liaison since she is on board and safety committee –
 Michelle thought that made sense.
- Reached out to Sherwood's Public Works Director, Craig Sheldon, about testing resources (Craig reached out to water utility manager). He gave her name of lab they used for their testing. A copy of the Sherwood water quality report showed the water quality surpassed federal and state standards.
- Checked in to what information was available from the Oregon Health Authority can use their resources but will need to create a plumbing profile for the school
- Contacted several qualified labs procured from ORELAP (Oregon Environmental Laboratory
 Accreditation Program) from a list that was 4-5 pages long whittled down choices to drinking water,
 inorganic, close to SCS
 - o Renée contacted **Alexin Analytical** (<u>link</u>)— 99W in Tigard and asked questions related to testing:
 - Will do analysis but not collection (sample early in the day 6-6:30 AM)
 - Sampling simple and straightforward
 - Sampling bottles are supplied

- Should test for lead and copper? (Copper testing not expected and done based on perception of need – done to cover liability)
- Labs

Alexin Analytical

- Pricing (1-10 samples -- \$25/each, 11-99 samples -- \$20/each)
- 1st and second draw sampling
- Testing a month behind can invoice without starting testing to hit our reimbursement deadline

• Edge Analytical

- o Pricing (\$28 and with school discount \$24)
- 10 working days turnaround for results
- For SCS Safety Committee identified 14 lead samples needed (fountains, water cooler, kitchen sink, etc.). Kids filling water bottles out of bathroom sinks in portables.
- Total lead testing costs
 - \$280 for \$20/each (Alexin Analytical) [\$560 for every tap (\$20/sample)]
 - \$20 lead (Pb) alone \$28 lead (Pb) + copper (Cu)
- Recommended we create a school/church plumbing profile
 - Get with Tim Brandt and Priscilla in church office (they've only done backflow testing). Church member "Jack" had talked about work done in the past to replace pipes from road to church being completed.
- Talk with Modern Building (portable supplier) to ask questions about plumbing used in portables
- Renée recommends make determination on testing options by next board meeting

The board unanimously thanked Renée for all her hard work!




Comparison Data


Test Results - School Comparison




Sherwood Charter School vs. Like School Average




English Language Arts 2015-2016 vs. 2014-2015








Staff is watching webinars of Bar Models in Singapore Math and also working on the assessment technology called Math On. I continue to observe Singapore Math on my "walk abouts" and also doing Keeper and Polishers in this month.

Safety

Pace visits our school October 21st for their annual check up. Earlier this month, the whole school participated in a bus evacuation drill through from the district. On Monday, we will have a brief Safety Assembly before our morning Code Red Drill. The staff has been trained in the drill. Parents will be alerted about the drill in Thursday's email. We will also test our Flash Alert system at the same time. After the drill, we send parents an email reporting how it went. On October 19th, we had a fire drill and the whole school was out of the building in less than two minutes, which is always the goal. That is good progress for October! On Thursday October 20th, SCS will participate in the Great Oregon Shake Out, which is an earthquake drill. We also have recently checked our earthquake kits to be sure we have a 3-day for the whole school in case of an emergency.

Technology

Everything seems to be up and running well. If you consider our copier downstairs technology, it has not worked well and seems to be constantly breaking. The office is on the case.

Annual Report

The Annual Report and other deliverables were delivered to the district on time. We are awaiting the audit to be delivered due to some editing errors on the document. The district is aware of this and said "no worries."
