#### Administrator report: Joy Raboli (Principal)

Ideas like a lunch assistance, food pantry, uniform assistance.

3. Install age appropriate playground equipment for k-8.

We will talk to Tonya to look at reserve funds. In speaking with PACE insurance the two highest dangers for a playground is, one, how it is installed, and two, not having one at all is equally dangerous because kids get bored.

We are working with the district to allow us to have access to more of synergy. We don't have access to some of it and it's very time consuming to work around.

Korrin: Why won't the district include us in the district lunch program? Joy: The district will not allow us to be part of the lunch program because we don't have a full industrial kitchen and the food would have to be delivered. They came out and as much as they would like to, they couldn't make it happen. We are looking at alternative solutions. Gina: What about the program we had before covid? Joy: That was PAC run and was a lot of work, they tried to bring it back but it's not financially beneficial for the restaurants anymore, and the PAC doesn't have the volunteers.

Gina: About the Food pantry, what about the church do they offer anything like that and we could partner? Joy: That's a really good idea, they have a Pantry and that could be something to bridge us with the church.
